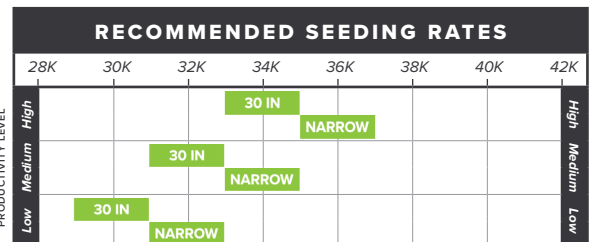
- R** **Light Soils:** Low O.M., Low CEC, Low water holding capacity.

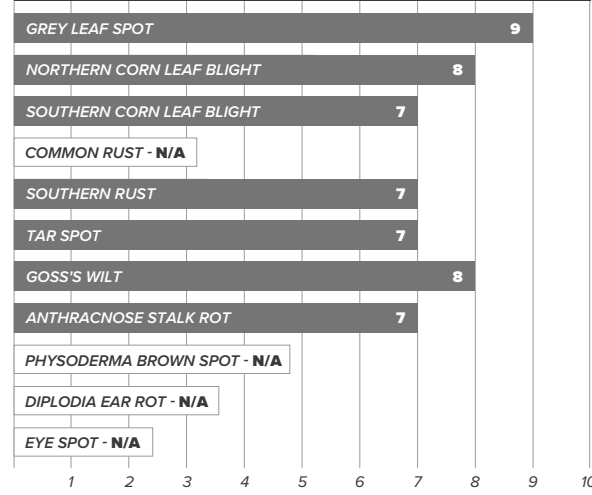
